**Policy and Contract Terms**

This photo session contract, entered into and made this day (today's date) \_\_\_\_\_, between A.U. Professional Photography (hereinafter referred to as Amber Urioste, "Photographer") and (enter company name) \_\_\_\_\_ (hereinafter referred to as "Client").

- *Session deposit is NON-REFUNDABLE and covers the Photographer's time and talent and they secure Client's session date and current prices. The deposit is applied toward the total cost of the session. If the session has to be rescheduled, then it is applied toward to agreed upon day and time.*
- *To secure date and time, the contract must be signed and agreed upon by all parties and the deposit made.*
- *The Photographer's camera is the only camera allowed at the photo session because of the distraction it causes and hinders the Photographers' ability to obtain quality shots. It also interferes with the flash channels on the Photographer's camera.*
- *If the Clients/Subjects become ill, please contact Photographer as soon as possible to reschedule. Request for rescheduling or re-shoots are granted by Photographer and at the Photographer's discretion. The Photographer reserves the right to reschedule the shoot for any reason within a 48 hour notice (usually weather related).*
- *Photos will be posted in the Photographer's Dropbox online gallery account for 360 days, and the client will be given a link via email to access these photos to preview. PLEASE NOTE that the photographer has a color calibrated monitor, therefore, the colors are to be true to "real life" and for web and printing purposes. What the client sees from his/her monitor may not be accurate to what is calibrated with the specifications needed for print and web based materials.*
- *Client is responsible for inspecting and downloading all images from the Dropbox link provided of final images.*
- *Photographer retains the sole discretion to edit images based on her professional opinion.*
- *Photographer will not begin work until all deposits are complete, and payments in full are before the images are delivered.*
- *Changes to images after the order has been placed requested by the client are subject to additional charges of \$25 per hour, and image change fees will apply regardless of Client's purchase.*
- *Clients requesting design work will be allowed 3 minor changes (changes to color, text, style/effect) without charge before an order has been finalized and reviewed.*
- *Client will be responsible for an additional \$25.00 service charge for any checks returned by the bank and photo sessions/orders will be cancelled within 3 days of notification that payment is not made in full.*
- *There will NOT be any raw or unedited images included. Images will be chosen by Photographer for quality, color, accuracy and composition. This means not every file from the session will be included in the image presentation. All raw images will have logos, and only the images purchased by the client will not have the logos.*
- *All images created by A.U. Photography LLC. are copyright protected, and A.U. Photography LLC. reserves the right to use the images and/or reproduction for display, publication, contests, and web site examples.*
- *"All Rights" pricing is included in this contract, and a separate release form will be provided to client.*
- *If any provision of the Contract is held to be invalid or unenforceable, all other provisions shall nevertheless continue to be in full force and effect.*
